#### Minutes

#### Public participation

Members of the public raised the following issues:

A proposed bike track event on DPC land was discussed. It was pointed out that this is not a
DPC supported event and any liability for loss or injury of any party taking part would be the
responsibility of the "organiser". The provision of a permanent facility would be supported by
the Parish Council subject to finding a suitable location and securing the necessary funding.


The youngsters asked with obvious support of the community so we investigated the possibility – we have secured the funding but would like to secure further funding to get the best possible facility for this group of the community.

We asked the youngsters not to use the woods, they have been patiently waiting for the facility.

Covid-19 restrictions have hampered the communication process of this project however the Community Consultation was planned when all information had been obtained.



## The original 2014 plans



On the 2014 plan and survey, the skateboard park was planned (smaller than a pump track) in the area of the current dog bark.

Since that point the Parish council has managed to achieve the following:


- Secure a larger Multi Use Games Area (MUGA) that accommodates football, cricket, tennis basketball etc.
- Protected the play are against rogue footballs be placing the MUGA between the football field and the play area.
- Facilitated a zip wire and table tennis tables.
- Facilitated a Dog agility run
- Facilitated better drainage for the field.
- Secured funding for the pump track.
- Agreed a 5 year plan with Wychbold Juniors Football teams
- Been approached by a local cricket club
- Been approached by an archery club.

# **Pump Track Locations Considerations**



There are three locations that have been muted both within the Parish Council and within the community.

#### The Old Children's play area (Size 21m x 8m)

- This was not considered large enough to facilitate a pump track to meet the needs of the age group.
- The location was dangerous being next door to the carpark.
- The noise level would disturb local residence.
- Due to H&S regulations, this area would only facilitate a pump track of dimensions 15m x 2m.

#### The area currently known as the Dog Bark Park

- Although a large area, this would infringe on the football field and be outside the five year agreement with Wychbold Juniors football club.
- The dog back park is not under CCTV.
- To the side of the back park is the drainage channels, in place to prevent excess water forming on the football field (paid for by Section 106 money). Wychavon would not allow the moving of all this.
- Due to H&S regulations, this area would only facilitate a pump track of dimensions 3m wide due to the location of the football pitch

### The top of the play area (Size 16m x 65m)

- This area is covered by 24 hour cctv which can be zoomed in to.
- The land will have to be landscaped but this will be factored into the costing.
- It will be accessible by all groups.
- Large enough to make a decent sized pump track for the teenage group.
- It is not lit however this will discourage night usage.

## **Pump Track Construction**

We received the following from the national lottery funding

#### Good afternoon

I've been assessing your recent application to the Community Asset Fund. Your project was discussed at our peer review, the consensus at this discussion was that we are not supportive of this modular type solution for a pump track and we would like you to investigate an alternative approach such as a pre-cast concrete or other more traditional construction methods. In the light of this decision, could you please let me know if this is something you are willing to consider?

The reason behind this choice is the length of guarantee on the structure.


## **Design and Build**

7	Paul Bradley	Top area makes the most sense to keep the kids using it away from the entrance, cars, entrance to the kids enclosed playground




# 6. Pump Track Comments

8	Nora O'Leary	I understand Evesham will be installing a state of the art pump track (not sure what it's called) in the near future, so perhaps if we had a smaller one it would be better. As we all know youngsters get fed up with things and fashions change. Installing new things is all very fine but these need ongoing maintenance/repair/replacment which could put a strain on funds. Raising the precept will not be received well by the Community. Because of the ground contitions (clay/salt) concrete could be a major problem.
9	Norma Edge	Questions 3 and 4 are leading questions. Why shouldn't we consider the 2017 plans which are more recent than 2014? This has not been put in as an option. If equipment can be moved from the top of the field, then it should be an option to move equipment in the middle and lower parts of the field. The middle of the field isn't given as an option, and yet it is more accessible to all members of the community (which was at the top of the Pelland Pump Track Site Selection criteria list). It is also nearer to facilities (a requirement of the users) and parking, and negates the need for any changes to the allotment access (and any associated costs both financially and to the natural environment). A socially-distanced site visit hasn't been carried out by the current Council. Surely we should be doing this, which would enable us all to discuss it at the same time, and in turn will help with our decision-making. This would give us an opportunity to talk to any members of the public who are present about what we are doing. N.B. The workshops in relation to the Legacy Fund weren't consultations, and weren't well attended (if at all), the first because of lack of notice.
10	Doug Webb	We should look to minimise the environment impact of the track with other environment positive elements to ensure this is done in an ecological manner.

1	Carry Smart	Move the gate further in for safety, cars can turn in the field but they can turn safetly off Stoke Road
2	Maureen Addy	The proposed new gate way would in my opinion be much better placed. Yes there is a slight bend but not as much as the present one.
3	Robert Keane	The statistics do not represent this as being a dangerous road and we need to ensure that we manage the new entrance in such away that is the visibility is at its maximum. This may involve removing more hedge than just a gate width but the planting of new growth in the wooded area will combat the ecological loss.
4	John MacDonald	I have personally seen a car stop on the main road while someone opened the gate, I thought this was dangerous. If we are going to have a gate of the main road then the gate needs to be set at least a cars length of the road so a car can pull in then open the gate without being any obstruction on the main road. If the gate cannot be moved then i would recommend the gate be removed and use the car park at the Village Hall.
5	Nora O'Leary	Perhaps when the the pump track diamensions/type is available we will be able to have further discussions about the entrance/entrances. However, I object to (Option 1) but fully support (Option 2). o
6	Norma Edge	A socially-distanced site visit is needed, and should include the users of the access as part of the consultation. The memorial orchard is a community asset, and to decimate it unnecessarily may lead to a backlash from the public. If markers could be put down to show exactly where the different options would be, and how much of the hedgerow/habitat/trees/greenery would be affected, this would help to inform our decision-making.
7	Doug Webb	By moving the gate it will ensure that any future financial impact to the council and taxpayers is minimised in continuing in providing access to the top area and allotments and it will also allow the opening up of the existing track along the wooded area to increase the biodiversity of the area.

ID↑	Name	Responses
1	Carry Smart	This also needs further investigation
2	Maureen Addy	This would be beneficial for the allotment holder. Also having spoken to Fiona's husband who the orchard is in honour of he has given his full blessing about moving some of the trees inward a little and a hard standing being placed there. He has also offered to help in any way
3	Robert Keane	The result of the planning permission with determine whether this becomes a hard standing or drop off point. I also believe that the planners will take into account all the relevant factors when making their decision.
4	Norma Edge	A socially-distanced site visit is needed, and should include the users of both the access and hardstand to see what they think. Gate options 2 (woodland) and 3 (existing) would not impact the memorial orchard. Presumably the hardstand would be in the same location for both (end of the woodland, by the allotments).
5	Doug Webb	The hard standing should be of a environmentally sound type and not in my view tarmac. It should be for a maximum of two vehicles at most. Should the parking area not be viable then I support a fall back option of a drop off point.

One Parish Councillor disclosed another declarable interest after the discussion and vote. This was discussed with the legal team who confirmed the vote result still stood.

Councillors do not see how other councillors vote when using the online process.
